Parking in meadows. Camp elev. 6300, trail 7400. Gas/diesel available in Sonora and Cold Springs. No gas in Strawberry.

Amenities: Horse water available, parking is level in parking area and surrounding meadow. Flush toilets in the lodge. Lodge has seating outside and inside for meals.
